1. The transportation of hazardous wastes and other waste will be done as per the section 17 and 18 of the Hazardous & other Waste (Management & Trans Boundary Movement) Rules, 2016 of MoEF and CC Govt. of India.
2. The actual user will recycle, reuse, reprocess or manufacture any item out of above imported waste within their own premises.
3. The actual user will ensure that the emission/effluent/hazardous waste if any are treated and disposed as per the prescribed norms. The actual user should have valid Air, Water consent under Air act, 1981 and Water Act, 1974 respectively and authorization under Hazardous & Other Waste (Management & Trans Boundary Movement) Rules, 2016.
4. Importer shall inform U.P. Pollution Control Board as soon as the waste arrives at port and send quarterly report at U.P. Pollution Control Board.
5. Any direction issued by U.P. Pollution Control Board shall be complied with.
6. In no case, the imported waste shall contain any constituent prohibited under the schedule of Hazardous and Other Waste (Management & Trans Boundary Movement) Rules, 2016 as amended.
7. The applicability of Registration is subject to direction issued by Ministry of Environment & Forest, Govt. of India.
8. The imported wastage shall be supplied/sold to the authorized recyclers/users only.
9. The unit shall comply with the provisions of notification no. G.S.R. 798 (E) dated 12.11.2021.
